**MINUTES**

Mayor Goodgame called the meeting to order.

Those present: Mayor Goodgame, Councilors Greene, Howard, Larsen, Lively, City Manager Lapeyrouse, Chief Dills, and City Clerk Cantrell.

Cathy Turner gave the invocation. Mayor Goodgame led the Pledge of Allegiance.

**SPECIAL BUSINESS**

City Clerk Cantrell administered the oath of office to Councilor Milner Lively.

**APPROVAL OF MINUTES**

Councilor Larsen made a motion to approve the minutes of the January 27, 2015 Regular Council Meeting, 2<sup>nd</sup> Councilor Howard, unanimously approved.

**ADOPTION OF AGENDA**

Councilor Greene made a motion to adopt the agenda, 2<sup>nd</sup> Councilor Larsen. Councilor Howard said he would like to add a Resolution Honoring the Service of Councilor Whatley to the agenda. Councilor Greene amended his motion to include this addition. The motion passed unanimously.

**MAYOR'S REMARKS**

Mayor Goodgame said he spoke at the State of Rabun address. It was recorded by Sky 104, and they are airing segments of it on the radio.

He said that Councilor Lively spoke to someone with the Georgia Municipal Association, GMA, about the situation with the Verizon cell tower. GMA recommended contacting their legal division to see if they can assist us in finding out information. We continue to pursue every avenue possible in working with Verizon to have the cell tower installed as soon as possible. He added that Verizon has been selling some of their wireless division to Frontier, and he does not know if this is impacting the Sky Valley tower or not.

We have added a new event to our marketing events this year – a beer fest on Memorial Day weekend. City Clerk Cantrell has been working very hard on this event.

We are also continuing our landscaping and beautification work. We will have a joint beautification and marketing committee meetings to help schedule during the year when different beautification projects should be done. We are working on a landscape plan for visitor center and an area where people can have a picnic lunch.

## **COUNCIL REMARKS**

Councilor Larsen said he would like us to contact Georgia Power because they put an electrical box just a little past where the pavement ends on Knob Drive that is incredibly crooked. He wants to see if we can get it leveled.

## **CITY MANAGER & DEPARTMENT REPORTS – EXCEPTIONS AND QUESTIONS**

City Manager Lapeyrouse reported on the snow from February.

We should have all of our garbage equipment in by the end of April, but we are going to move forward with the city picking up trash on Mondays and recycle on Thursdays beginning April 6<sup>th</sup>. We have had several complaints about garbage being missed by Waste Away, so we are looking forward to providing this service in-house again.

City Manager Lapeyrouse reported that the Beer Festival and 5K tickets will be live and on sale by the end of this week.

Mayor Goodgame said that because of the snow, we were unable to meet last month. He said that some of the outlying and steeper roads are very dangerous for the city employees and our equipment to handle. We are looking at subbing out scraping some of these streets. We had a situation where a police vehicle almost slid off a very steep road. We understand that everyone wants to be able to get out and drive, but we have to put our employees' safety ahead of clearing the snow. He said that we contracted with someone to use a four-wheeler to clear some areas, and we will continue to do so in the future.

## **NEW BUSINESS**

- Resolution – Healthcare Reimbursement Plan

Mayor Goodgame said this is part of the transition from the group plan we had with GMA to a reimbursement plan and provide the same level of benefit to the employees. City Manager Lapeyrouse said that allows the city to reimburse the employees for their health insurance. She explained that now, each employee is responsible for obtaining health insurance, and that this plan allows the city to reimburse them up to \$700.00 per month. Councilor Greene made a motion to approve the reimbursement plan, 2<sup>nd</sup> Councilor Howard. Councilor Howard said there was no cost schedule attached to this and asked about the rates. City Manager Lapeyrouse explained that the plans are through the healthcare marketplace and rates are based on family income so each employee's rate is different. She said that this reimbursement amount was sufficient to cover each employee's cost for health insurance, and it is less than what the employee-only premium was with the group plan. The motion passed unanimously.

- Proposed 30' x 30' easement to Windstream for new switchbox near Sky Valley Fire Station

Mayor Goodgame presented the proposed easement and said that the area had been flagged, and it is very unobtrusive. City Manager Lapeyrouse added that it will help reduce the demand on another switchbox and will help with internet speeds. Councilor Greene made a motion to approve, 2<sup>nd</sup> Councilor Howard, unanimously approved.

- Modification of Members of the Visitor Center Committee

City Clerk Cantrell said that Lynn Becker and Myrna Warner would like to serve on the Visitor Center Committee. Councilor Larsen made a motion to add them to the committee, 2<sup>nd</sup> Councilor Greene, unanimously approved.

- Bates-Carter Engagement Letter for FY 2014 Audit

Mayor Goodgame presented the audit engagement letter adding that Bates-Carter did a wonderful job with last year's audit and helped us get some prior years' adjustments made. Councilor Larsen made a motion to approve, Greene, unanimously approved.

- Event Dates
  - Beer Festival and Run – Saturday, May 23
  - Fall Fest – Saturday, October 17

Mayor Goodgame said we want to approve dates for the Beer Festival and Run and the FallFest. Councilor Howard made a motion to approve the event dates as stated, 2<sup>nd</sup> Councilor Greene, unanimously approved.

- Ordinance – Fee Schedule

Mayor Goodgame said that we have an ordinance that sets fees for garbage and water rates and also for different types of inspections and services we provide. We need to update this ordinance because we changed the water and garbage rates, and we also want to change some of the permit fees for work to your home to a flat fee of \$75.00 to help encourage home improvements. He said he wanted to change the language for unfinished areas under building permit fees and make that a flat fee of \$75.00 as well. Councilor Howard made a motion to approve the Fee Schedule Ordinance with this change, 2<sup>nd</sup> Councilor Greene, unanimously approved.

Helen Kleiber asked if there is a fee for when we have to go pick up scattered garbage. City Manager Lapeyrouse said our garbage ordinance does allow us to charge a fee, however we need to update the garbage ordinance, and we will need to discuss that along with the new ordinance.

- Community Garden

Mayor Goodgame said he was starting heirloom tomato seeds, and when he was researching this, he discovered that community gardens are on the upswing. He said that City Manager Lapeyrouse had researched this previously but it never got off the ground. He asked if the council was interested in this that we pursue a community garden. Councilor Greene made a motion to approve creation of a community garden, 2<sup>nd</sup> Councilor Larsen, unanimously approved.

- Resolution Honoring Councilor Whatley for his Service to the City

Mayor Goodgame said that we have a special session on the April agenda to honor Councilor Whatley and present a plaque to Kristen at that meeting. Councilor Howard read the Resolution and made a motion to approve, 2<sup>nd</sup> Councilor Greene, unanimously approved.

## **PUBLIC FORUM AND GENERAL COMMENTS**

Steve Brett thanked Officer Edwards for his assistance during the snow storm.

A resident asked if the City will be pursuing the Neighborhood Watch program and signs. Mayor Goodgame said that we have a Neighborhood Watch Committee, and that we will be installing the signs. He added that the signs are privately funded.

Debbie McAfee asked when the Visitor Center Committee should plan to meet and staff the visitor center. Mayor Goodgame said that they will want to meet at the end of April or early May, and that City Clerk Cantrell will be organizing a meeting.

Bob MacNair asked if we will pay for the Visitor Center parking lot paving with our SPLOST money because there are also several streets that need to be paved. Mayor Goodgame said that the city has received SPLOST funds of \$350,000 toward paving and has \$75,000 saved from 2014 plus what we budgeted for 2015. All of these funds will be combined for the 2015 paving projects.

Susan Cillo asked where we are on negotiations with Merrill to tear down the old lodge. Mayor Goodgame said that they are dead. He said we can force him to tear it down, however if we do, we put our monthly leases with him in jeopardy such as the waterfall and the city park. He said he is concerned with us losing the only recreational assets we have. He also owns the overlook on Hwy 246, and he has allowed us to have our sign there. Our biggest priorities are getting cell service and sewer. He met with a County Commissioner this morning discussing sewer, and he said that the County Commission is aware that if Sky Valley had sewer and could have some development, it would also help the whole County generate tourism and income.

Lynn Becker said that on Sky Valley Way, heading toward the entrance, from the speed bumps to the entrance on the right, it would look much better if some of the brush was cleared. Mayor Goodgame said we would check to see if that is on right of way or golf course property and see about it being cleaned up.

Councilor Larsen made a motion to go into executive session, 2<sup>nd</sup> Councilor Greene, unanimously approved.

#### **EXECUTIVE SESSION**

Councilor Howard made a motion to reconvene regular session, 2<sup>nd</sup> Councilor Greene, unanimously approved.

#### **Personnel**

Councilor Larsen made a motion to approve personnel changes of:

Isaac Cannon – from part time to full time public works employee

Jerry Shope – moved from police officer to public works department

Cory Justus – from on-call officer to full time officer

The motion was seconded by Councilor Greene, unanimously approved.

#### **Real Estate**

Councilor Larsen made a motion to approve Mayor Goodgame and City Manager Lapeyrouse to discuss a possible real estate acquisition with the property owner, 2<sup>nd</sup> Councilor Greene, unanimously approved.

Councilor Howard made a motion to adjourn, 2<sup>nd</sup> Councilor Greene, unanimously approved.

**2015 Keep America Beautiful**

Sky Valley will participate in the 2015 Keep America Beautiful Campaign by having a Spring Clean-up Day during the week of May 18th. We will e-mail the exact date and time to meet at City Hall. We appreciate the record number of volunteers that came out to help last year. This is the week before our big festival so we want Highway 246, Bald Mountain Road and all of Sky Valley looking its best.

**Sky Valley Craft Beer Festival & Mud Creek Falls 5k**

May 23, 2015 will be Sky Valley's first Craft Beer Festival and Mud Creek Falls 5k. Tickets are now on sale through the City's website at [www.skyvalleyga.com](http://www.skyvalleyga.com). There is a discount for the first 100 registrants for a combination race/festival ticket. Beer Festival Tickets are limited. There will be ten local craft brewers from GA and NC represented, each offering three craft beers. Ticket holders will be given a tasting glass for sampling and there will be live entertainment throughout the event. Race starts at 10 AM, with packet pick-up at 9 AM. The Beer Festival starts at 11 AM for VIP ticket holders and 12 PM for regular admission.

The following are some concepts related to craft beer and craft brewers:

- Craft brewers are small brewers.
- The hallmark of craft beer and craft brewers is innovation. Craft brewers interpret historic styles with unique twists and develop new styles that have no precedent.
- Craft beer is generally made with traditional ingredients like malted barley; interesting and sometimes non-traditional ingredients are often added for distinctiveness.
- Craft brewers tend to be very involved in their communities through philanthropy, product donations, volunteerism and sponsorship of events.
- Craft brewers have distinctive, individualistic approaches to connecting with their customers.
- Craft brewers maintain integrity by what they brew and their general independence, free from a substantial interest by a non-craft brewer.
- The majority of Americans live within 10 miles of a craft brewer.

All participants are encouraged to drink responsibly and bring a designated driver.

### *Tax Collections*

#### **Delinquent Tax Penalty**

Sky Valley real estate taxes were due February 6, 2015. In addition to the one percent interest that is currently accruing on any unpaid ad valorem taxes, a ten percent penalty will be assessed May 15, 2015 and a lien will be filed. Please contact Alyssa Mullins at City Hall if you have any questions about your Sky Valley property taxes.

#### **Homestead Exemption**

If you are not currently claiming the homestead exemption in the city and the county separately, you must file in person between January 2 and June 1. Qualification requires that you must own and occupy the property as of January 1 as your primary domicile and legal residence for all purposes, which includes the registration of your vehicles and filing of your state income taxes. Exemptions are not automatically granted. Special exemptions are available if you are 100% military service connected disabled or their un-remarried spouse, or the un-remarried spouse of a peace officer or firefighter killed in the line of duty. Once approved, the exemption remains in effect as long as you own and reside in your home subject to periodic audits to verify continuing eligibility.

#### **Short-term Rentals**

It is mandatory that every person engaging in short-term home rentals of 10 days or less must register with the city clerk. If you have not done this yet, I urge you to contact City Hall immediately. Each rental within the City limits of Sky Valley is required to submit a monthly tax return by the 20th of the month for rentals during the previous month. An operator who fails to make any return or to pay the amount of tax will be assessed penalties and interest.

### *Housing & Development & Code Enforcement*

#### **Permits**

Please be reminded that work done on your home may likely require a permit. When in doubt, please contact the Building Inspector's Office or City Hall. If you are found to be doing work without a permit, your first offense will subject you to a penalty fee equal to double the cost of the permit, a \$50 minimum. The homeowner is ultimately responsible

for making sure his/her contractors obtain the necessary permits. Permits are required for, but not limited to, all structural, mechanical, electrical, plumbing, soil & erosion, roofing, decking, stairs, concrete, tree cutting, additions and remodeling. Many repair permits have no cost associated with them but are still required and will still be subject to the penalty fee if they are not properly obtained.

### *Public Works -*

The Public Works Department is working hard to improve the over-all appearance of the City's road right-of-ways. They are also beginning to start road patching. Please pay special attention to areas that are coned off. These are areas being patched and may be dug out to get ready for asphalt. They have had a busy month of chipping with the high winds and homeowner spring cleaning that has been going on. After all of the recent rain, we will also be checking ditches and culvert heads to improve storm water drainage throughout the city.

### **Safety**

Public Works Employee, Neal Chastain attended Safety Coordinator training in Cornelia. He is the designated Safety Coordinator for the City. Having a good safety program entitles the City to qualify for grants through GMA's liability and workers compensation insurance programs. This year, the City has already been granted over \$2300 through this program in reimbursable expenditures for safety gear.

### **Tree Cutting/Trimming/Topping**

Please don't forget that any tree with a trunk that is 8" or more in diameter or 25" or more in circumference at 18" above the ground requires a permit for cutting, trimming & topping. You are allowed to remove limbs from a tree up to twelve feet above the ground without a permit. If you had to obtain a permit to cut, it would not qualify for city chipping service. Contractors are responsible for the removal of all tree cuttings and debris within fourteen days.

### **Chipping Service**

The City provides 15 minutes of chipping service to every homeowner each month at no cost. Chipping service is then provided at a rate of \$100/hour for any time exceeding the first 15 minutes. Cuttings must be less than 8" in diameter and must be stacked in one direction on the right-of-way, out of the road and not in an area that will block culverts or otherwise impede storm water drainage. We cannot chip small yard debris, vines, thorn bushes, small shrubbery clippings, railroad ties, landscape timbers, or similar type items. The chipping service is designed for limbs and small trees only. All other yard waste must be bagged.

### **Leaves and Yard Waste Pick-up**

Yard waste is collected separately from household garbage. Please call City Hall to let us know you have yard waste to be picked up. Yard waste shall be bagged and placed for pickup within 5 feet of the roadway. Please do not mix household garbage in with this material.

## Mulch

Mulch from our chipping service is available for purchase from the City for \$25 per load delivered.

## Water -

Don't forget that we offer automated bank draft for water/garbage billings. Please contact Alyssa Mullins at City Hall to sign up for this service. Remember, your account will automatically be drafted for the total amount due each month. You will still receive a paper bill so that you can continue to audit the water usage and billing amount each month.

## Solid Waste -

The City's new garbage truck has been delivered. We are now fully operational with our garbage and recycling pick up. Household garbage will continue be picked up on Mondays and recycling on Thursdays. Please do not put garbage out on Thursday. If you need to dispose of garbage during the week, you are welcome to us the dumpsters on Knob Drive behind the postal facility. The dumpsters will soon be replaced with our compactor. The compactor has been delivered, but they are still working out some issues with the concrete pad.

The bears are very active so far this season. Don't forget that garbage should not be placed out for pick-up any earlier than the morning of the service. Animals scatter garbage even when put in the underground cans. Our garbage collectors are not responsible for picking up any garbage that is not properly bagged once they arrive. The dumpster at the tractor barn on Knob Drive can be utilized when you need to take your garbage somewhere prior to a garbage collection day. This is especially important when your garbage contains food items. NO garbage other than regular household garbage should be put out by the road or in the dumpster. **Any contractors or residents found dumping lumber, carpeting, paint, etc. in the dumpsters will be cited.** Construction debris should be hauled to the transfer station on Boggs Mountain Road in Tiger.
