#### 1. Call to Order

Mayor Steil called the meeting to order.

#### 2. Adoption of Agenda

Councilor Turner made a motion to adopt the agenda as presented, seconded by Councilor Morley, unanimously approved.

#### **NEW BUSINESS**

- 3. Discuss using part of the ARPA (American Rescue Plan Act) funds to provide premium pay to City employees who have worked through the COVID-19 pandemic City Manager Streetman talked about funds that public safety personnel, Police Department, are eligible for, though the Governor's Office. This is a one-time eligibility in the amount of \$1,000 per officer for working through the pandemic. The recommendation is to use part of the ARPA funds to match this amount for the rest of the non-public safety staff to show appreciation for their work during this time also. The City of Sky Valley has received approximately \$51,000 in 2021 and is slated to receive the same amount in 2022. The amount recommended to be paid for this match would be \$11,500.
- 4. Discuss purchasing one (1) Dodge Durango AWD/SUV for the police department City Manager Streetman stated that he attempted to obtain quotes but only one responded, Smoky Mountain Dodge in Franklin N.C. The quote was for a Durango AWD Pursuit Vehicle in the amount of \$38,684.00. The cost of the vehicle would come out of the SPLOST funds and would be for the replacement of a Subaru, that is in use now. If approved, this would put the City's name on a waiting list for an estimated delivery date of April or May.
- 5. Discuss purchasing two (2) Kubota RTVs with snowplows for the road department and water department

City Manager Streetman received three quotes on RTVs, a heavy-duty all-terrain vehicle. All three quotes were similar in price, but Kubota Tractors of Franklin has two coming in during the next couple of weeks. These vehicles would be used by the roads and water department. They will be equipped with snowplows to aid in snow removal to the water tanks and clearing of roadways. During the warmer months they could be used to haul small equipment and to read meters. Public Works Superintendent stated that Steve Mason uses a Polaris for snow removal and has very good results as you can get into tighter places. Two RTVs would help cover the City faster as they could start on opposite ends.

### 6. Discuss utilizing the services of Liquid Engineering for the cleaning and maintenance/repair of City water tanks

City Manager Streetman has been in touch with Liquid Engineering out of Montana. The City has used their services in the past. Periodic cleaning of the tanks and inspections are needed and the City is past due for this service. The quote that was given for the cleaning and inspection was in the amount of \$5,560.00. The tanks can be checked while full and any maintenance can be preformed at that time under full sanitary control.

#### 7. Discuss Smart Earth Technologies pilot program options for meter reading

City Manager Streetman went over the test pilot program with smart Earth Technologies. Ten units would be at a cost of \$5,000. The test pilot program will be conducted for a six month period. These meters will be placed strategically through out the City. Proposed advantages of these units include giving alerts for high water usage along with the capabilities of cutting the meters off/on remotely.

#### 1. Call to Order

Mayor Steil called the meeting to order.

#### 2. Invocation

Councilor Oliver led the invocation.

#### 3. Approval of Minutes

Councilor Curtis made a motion to approve the minutes as written, seconded by Councilor Turner, unanimously approved.

#### 4. Adoption of Agenda

Councilor Oliver made a motion to adopt the agenda as presented, seconded by Councilor Curtis, unanimously approved.

#### 5. City Manager's Report

City Manger Streetman stated that he is working on some of the End-of-Year Reports along with the LMIG Grant application. Met with Precision Paving concerning next year's paving projects. Still waiting on Lamar Hare, contractor for the Sky Valley Way culvert project, and will seek another contractor if the project is not started soon. Southern Road project is sill being held up by one property owner concerning the easement. ServLine Protection Program will be in place starting January 1, 2022. Waiting on a quote from Talbot Tennis for a third pickleball court. Been in touch with Munnerlyn Pyrotechnics concerning the July 4th fireworks and was told it would need to be on the 3rd as the Dillard House will be on the 4th.

#### 6. Departmental Reports

**Public Works Superintendent Shope** stated that his department is fully staffed now. He introduced two new employees, Kenneth Queen and Larry Randolph. The department has prepared for any winter weather and the leaf vacuum is being used along with the tree trimming resuming.

Police Chief Estes stated that his department has been granted the Certification by the Georgia Association of Chiefs of Police and the United States Department of Justice under executive order 1329, known as <a href="Safe Policing for Safe Communities">Safe Policing for Safe Communities</a>, signed into effect by President Trump, October 28, 2020. The executive order is designed to improve accountability, build trust, and ensure the safety of the public as well as members of law enforcement who risk their lives every day. Less than 7% of departments is the state of Georgia and 10% in the Country, have this certification. The certification will help with qualifying for other federal grants.

#### 7. Committee Reports

Councilor Oliver, **Mayoral Advisory Committee** Chairman, went over what the committee is discussing: The recommendation for the building on 246 and the plans that Harrison Merrill, Jr., potential has for Sky Valley.

**Marketing Committee** – Mayor Steil reported for the committee and stated that Bob O'Keefe, former chairman, had just finished his term and has stepped down. The committee has a carryover balance of approximately \$3,000 to start 2022 of with.

#### **NEW BUSINESS**

8. Consider approval of Resolution to utilize American Rescue Plan Act (ARPA) funds to provide premium pay to City staff who have worked through the COVID-19 pandemic

City Manager Streetman went over the recommendation for issuing the non-safety personnel of the City, matching pay that the police department is slated to receive from the Governor's Office. The funding would come from the ARPA funds which the City has already received. This would cover all employees of the City that has worked through the pandemic.

Councilor Morley made a motion to approve the Resolution utilizing ARPA funds for premium pay to non-safety staff, seconded by Councilor Turner, unanimously approved.

9. Consider approval of quote from Smoky Mountain Dodge to purchase one (1) 2022 Dodge Durango SUV with police package for the Police Department, \$38,684

Councilor Oliver made a motion to approve the purchase of a 2022 Dodge Durango SUV from Smoky Mountain Dodge, seconded by Councilor Curtis, unanimously approved

### A RESOLUTION TO AUTHORIZE AWARD OF CONTRACT FOR EMERGENCY STORM DRAIN REPLACEMENT AT COUNTRY CLUB

WHEREAS, the governing body of the City of Sky Valley is the Mayor and Council; and

**WHEREAS**, it is necessary to immediately repair the culvert near a main road in the city because the road is in danger of being impassable;

WHEREAS, O.C.G.A. §32-4-113(a)(5) says "[a] municipality is prohibited from negotiating a contract except a contract ... for emergency maintenance requiring immediate repairs to a public road including but not limited to bridge repairs, snow and ice removal, and repairs due to flood conditions." (Emphasis added).

WHEREAS, the City of Sky Valley has inspected the damaged culvert and the Mayor and Council have deemed it a danger to the citizens of Sky Valley and have moved forward with getting a quote from a qualified construction firm to fix the culvert.

### NOW, THEREFORE, BE IT RESOLVED BY THE MAYOR AND COUNCIL OF SKY VALLEY, GEORGIA:

- **Section 1.** Contract Award. Curbow Construction Co. Inc. of Homer, Georgia is hereby selected to perform the work of fixing the damaged culvert, based on their estimated price of \$109,492.16, as listed on their December 20, 2021, quote and any revised quotes which reflect a change order to two 60-inch pipes, which are attached hereto and incorporated by reference.
- **Section 2.** Filing copies of final agreement. The City Manager is hereby authorized to execute the contract, and any other documents consistent with the above-referenced contract and file the final executed contract in the office of the city clerk where it shall be certified and made available for public inspection.
- **Section 3.** Severability. If any section, part, or provision of this resolution is held invalid, unenforceable, such invalidity or unenforceability shall not affect any other portion of this resolution, and all parts, sections, whereas clauses, and other provisions of this resolution shall be severable.

#### Recitals

Herein on the date above the City enters into a contract with the Contractor to perform the following construction work: As detailed within the attached itemized quote; contractor is to remove two (2) 48" metal culverts and replace with two (2) 60" HDPE (High-density polyethylene) culvert pipes, pour concrete headwalls, and repave road.

Said work is to be performed in accordance with the contract documents, the plans, and the specifications. Said plans and specifications have been prepared by or on behalf of the City.

#### Section 1 - Entire Contract

Contractor certifies and agrees that he is fully familiar with all of the terms, conditions and obligations of the Contract Documents, as hereinafter defined, the location of the job site, and the conditions under which the work is to be performed, and that he enters into this Agreement based upon his investigation of all such matters and is in no way relying upon any opinions or representations of the City.

It is agreed that this Agreement represents the entire agreement. It is further agreed that the Contract Documents are incorporated in this Agreement by this reference, with the same force and effect as if the same were set forth at length therein, and that Contractor and his subcontractors will be and are bound by any and all of said Contract Documents insofar as they relate in any part or in

any way, directly or indirectly to the work covered by this Agreement.

Contractor and any Subcontractor(s) are to be bound to City in the same manner and to the same extent as Contractor is bound to the City under the Contract Documents, to the extent of the work provided for this Agreement, and that where, in the Contract Documents, reference is made to Contractor and the work or specification therein pertains to a Subcontractor's trade, craft, type of work, then such work or specification shall be interpreted to apply to Contractor.

#### Section 2 - Scope

Contractor agrees to furnish all labor, services, materials, installation, cartage, hoisting, supplies, insurance, equipment, scaffolding, tools and other facilities of every kind and description required for the prompt and efficient execution of the work described herein and to perform the work necessary or incidental to complete all the work described. To complete the project in strict accordance with the Contract Documents and as more particularly, though not exclusively, specified in: Contractor's Proposal.

#### **Section 3 - Contract Price**

The City agrees to pay Contractor for the strict performance of his work, the sum of: One hundred nine thousand, four hundred and ninety-two dollars and sixteen cents. (\$109,492.16), subject to additions and deductions for changes in the work as may be agreed upon, and to make payment in accordance with the Payment Schedule, Section 4.

#### Section 4 - Payment Schedule

by the City and/or their representative, subject to the provisions of the next sentence. The retained percentage shall be paid to the Contractor promptly after all punch work is completed and accepted by the City. Contractor agrees to furnish, if and when required by the City payroll affidavits, receipts, vouchers, release of claims for labor, material and subcontractors performing work or furnishing materials under this Agreement, all in form satisfactory to the City, and it is agreed that no payment hereunder shall be made, except at the City's option, until and unless such payroll affidavits, receipts, vouchers or releases; or any or all of them, have been furnished.

And any payment made hereunder prior to completion and acceptance of the work, as referred to above, shall not be construed as evidence of acceptance of any part of Contractor's work.

#### Section 5 - General Provisions

- a) Contractor agrees to begin work as soon as instructed by the City, and shall carry on said work promptly, efficiently and at a speed that will not cause delay in the progress of work of the City or other Contractors. If, in the opinion of the City, the Contractor falls behind in the progress of the work, the City may direct the Contractor to take such steps as the City deems necessary to improve the rate of progress, including, without limitation, requiring the Contractor to increase the number of shifts, personnel, overtime operations, days of work, equipment, or other remedies and to submit to the City for City approval an outline schedule demonstrating the manner in which the required rate of progress will be regained, without additional cost to the City. The City may require Contractor to prosecute, in preference to other parts of the work, such part or parts of the work as City may specify.
- b) The Contractor shall complete the work as required by the progress schedule prepared by the City, which may be amended from time to time. The progress schedule may be reviewed in the office of the City and sequence of construction will be as directed by the

City.

- c) The Contractor agrees to have an acceptable representative (an officer of Contractor if requested by the City present at all job meetings and to submit weekly progress reports in writing if requested by the City. Any job progress schedules are hereby made part of and incorporated herein by reference.
- d) The Contractor shall schedule the work at the jobsite and any deliveries of supplies or materials by its material men and suppliers to the jobsite on such days, and at such times and during such hours, as may be directed by the City. Contractor shall assume responsibility for such schedule compliance not only for its employees but for all its material men, suppliers and subcontractors, and their material men and suppliers.

#### **Section 6 - Special Provisions**

- a) This contract is to be construed according to the laws of the State of Georgia.
- b) The contractor agrees to indemnify and hold the City harmless from any claim asserted against the City arising out of the work performed by the contractor under the terms and conditions of this contract.
- c) The parties agree that any dispute under the terms and conditions of this contract may be resolved by alternative dispute resolution as the same is authorized by the laws of the State of Georgia.
- d) The parties agree that Rabun County, Georgia is the exclusive venue for the resolution of any dispute under the terms and conditions of this contract.
- e) Some Subcontractors and/or Contractors are required by law to be licensed and regulated by the State License Board. The Contractor is responsible to abide by those laws.

**SUBJECT: 2022 Qualifying Fees** 

Pursuant to O.C.G.A. § 21-2-132(c)(3) & SB 199, the qualifying fee for the offices of two Council Member seats to be filled in the November 8, 2022, City of Sky Valley General Election, is set at \$15.00. Such fees shall be paid to the Rabun County Board of Elections and Registrations by any candidate seeking to have his or her name placed on the November 8, 2022, General Election ballot. A pauper's affidavit may be filed in lieu of paying the qualifying fee.

Qualifying for the offices listed above will begin at 8:30 A.M. on Monday, August 15<sup>th</sup> and will end at 4:30 P.M. on Friday, August 19<sup>th</sup>. There being two Council Members whose terms shall expire in 2022, qualifying will be to fill these two seats. Should less than two candidates qualify for the office of Council Member, qualifying will reopen on Monday, August 22<sup>nd</sup> at 9:00 A.M. and end at 5:00 P.M. on Tuesday, August 23<sup>rd</sup>.

#### **AGREEMENT**

### State of Georgia County of Rabun

Whereas, the CITY OF SKY VALLEY, hereinafter referred to as First Party, is a municipal corporation in said State and County, chartered by the General Assembly of Georgia, and

Whereas, the SKY VALLEY-SCALY MOUNTAIN VOLUNTEER FIRE & RESCUE DEPARTMENT, INC., hereinafter referred to as Second Party, is a corporation with an office and place of business located in said County, and

Whereas, the parties desire to enter into this Agreement for certain services to be performed for the benefit of First Party by Second Party,

Now, therefore, and in consideration of the mutual promises herein set forth and the payment by First Party to Second Party of the sum herein specified, it is mutually agreed as follows:

#### TERM OF AGREEMENT

This Agreement shall be effective when signed by both parties and shall continue in full force and effect until December 31, 2022. It may be renewed by the parties thereafter from year to year by a letter of intent to renew signed by both parties and attached hereto which shall specify any modifications hereof.

#### II. DESCRIPTION OF SERVICES

Second Party shall provided fire fighting and rescue services in the same manner and to the same extent as it has in previous years for dwelling houses and other buildings and surrounding and adjacent areas located within the City of Sky Valley.

#### III. AFFILIATION

Second Party is an Independent Contractor as to First Party and is not an agent or employee. The time and manner of performance shall be within the sole and exclusive discretion of Second Party taking into consideration the nature of the duties and obligations of Second Party as a fire and rescue service. First Party shall have no control over the same but Second Party shall cooperate with the Sky Valley Police Department and City Government and its employees in carrying out its duties and obligations.

#### IV. COMPENSATION FOR SERVICES

First Party will financially contribute to Second Party for its services in the first, second, third and fourth quarters of the year 2022 in the amount of \$24,312.76 per quarter for a total of \$97,251.04 for the year. This constitutes one and one half mils of the Net Digest Value of real property within the City (at 40% valuation) for calendar year/tax year 2021. First Party shall mail payment by check to

Second Party at P O Box 278, Scaly Mountain, NC 28775 in a timely manner each quarter so as to be received by Second Party not later than the last day of the second month of each quarter, i.e. 28 February; 31 May; 31 August and 30 November.

#### V. SPECIAL CONDITIONS

The following Special Conditions shall apply:

- (A) This Agreement is made in Rabun County, Georgia, and the law of Georgia shall govern the legal construction and interpretation of its provisions and the rights and remedies of the parties.
- (B) The provisions hereof constitute the entire Agreement of the Parties and no oral agreement, promises or inducements made by either Party shall bind the other unless reduced to writing and incorporated herein.
  - (C) This Agreement may not be modified except in writing executed by both parties.
